In order to provide high quality instruction, intervention, and extended learning opportunities, Westfield provides the following educational services to support student learning funded using categorical funds:

Targeted instruction for Transitional Kindergarten through 6th grade students using ELD Standards through Designated ELD instruction. The Designated ELD instruction is designed to support the Integrated ELD lessons that are taught throughout the day. Teachers meet weekly in professional learning communities to analyze data, monitor students' progress, and develop instructional plans to meet the specific needs of students.Before and After School Interventions- Teachers provide 6-week sessions to provide extended learning time through targeted, specific instruction based on individual students' needs based on multiple assessment data points.
